



**Manufacturer's Tax Credit Certificate - Nonbusiness Energy Property Credit**

**Internal Revenue Code Section 25C**

The Consolidated Appropriations Act, 2021 (P.L. 116-260) amended section 25C, which provides a tax credit for the purchase and installation of “qualified energy property,” including residential heating and cooling equipment meeting certain energy efficiency requirements. American Standard Heating & Cooling, a brand of Trane U.S. Inc., certifies that the products listed below contain advanced main air circulating fans with an annual electricity use of no more than two (2) percent of the total annual site energy use of the furnace (as determined under standard Department of Energy test procedure) that may be eligible for the section 25C tax credit if placed in service by December 31, 2021. **Other Important Homeowner Information**
